Please read these directions carefully before filling out this application. Please **print or type** and make sure all pertinent questions are answered completely and accurately. Should you have a disability for which you need special accommodation in order to participate in the application process, please request assistance from the Executive Director, Meredith Doyen.

Application deadline is Friday, April 15, 2016. However, applications will be reviewed on a rolling basis, and on-site interviews will be conducted throughout April and May. Applicants are encouraged to apply as soon as possible. Positions begin on July 1, 2015. Exceptions can be made to align with graduation dates.

IN-PERSON, ON-SITE INTERVIEWS ARE REQUIRED.

Some funding may be available for travel expenses.

FCAC Glass Arts Fellowship Eligibility: Completion of undergraduate or graduate degree, U.S. citizenship and applicant must be willing to undergo criminal background checks, including state and federal checks. Background checks must be implemented prior to the start of the fellowships.

A complete FCAC Glass Arts Fellowship application consists of the following items:

- This formal application form, scanned and signed, if submitting electronically
- A current CV or résumé that shows educational background and work experience
- A copy of your transcript (unofficial) and/or other documents of your complete undergraduate and graduate school record
- At least three written recommendations (may be e-mailed directly to Meredith Doyen)
- A personal statement (no longer than four pages). Your personal statement should be a narrative giving a brief profile of yourself, your professional development and your interest in becoming a FCAC Glass Arts Fellow
- At least 15 examples of your work
